- _____ Achieve a minimum Accuplacer Math placement score of 53
- _____ Hold a minimum Grade Point Average (GPA) of 2.0 on college work.
- _____ Complete BIO 2514, Anatomy and Physiology I; BOT 1133 or CSC 1123 and any other 2 of the following General Education courses.
 - BIO 2524 – Anatomy and Physiology II
 - PSY 1513 – General Psychology
 - SPT 1113 – Public Speaking
 - ENG 1113 – English Composition I
 - Humanities/Fine Arts Elective
- _____ Obtain a Criminal Background Check from a MGCCC Campus Police office. The CBC result is required prior to submitting the application. Please check the program's website for the Campus Police testing times.
