- _____ Complete the MGCCC College Admission Requirements

- _____ Review and Complete the **Mandatory** Pre-Health Sciences Orientation Session (*See website to access*)

Register for and successfully complete the following Prerequisites

- _____ Complete **BIO 2514** Anatomy & Physiology I. Grade in course must be of a “C” or higher to receive credit.
- _____ Hold a minimum cumulative Grade Point Average (GPA) of 2.5 on college work.
- _____ Achieve a minimum Accuplacer English placement score of 175
- _____ Achieve a minimum Accuplacer Math placement score of 53
- _____ Obtain a Criminal Background Check from a MGCCC Campus Police office. The CBC result is required prior to submitting the application. Please check the program’s website for the Campus Police testing times.
- _____ Optional; additional points towards admission ranking will be awarded for successful completion of the following academic core course: ENG 1113, PSY 1513, MAT 1313, CHE 1214 or 1314, SPT 1113, and a Humanities/Fine Art Elective
- _____ Optional; Phlebotomy (ASCP) Certification (*Additional points will be awarded to those who hold this certification*)
- _____ **Prior to the deadline, but after successful completion of the above program entry requirements, submit the supplemental Medical Laboratory Technology Application.
