Register for and successfully complete the following Prerequisites (Maintaining a 2.5 GPA)

The following Courses are additional Non-Nursing courses that may be taken after making application to the program. However, it is strongly encouraged to complete prior to submitting the application to enter.

- BIO 2524 (Human Anatomy & Physiology II)
 - _____ ENG 1123 (English Composition II) 3 hour computer course (College Requirement) ____EPY 2533 (Human Growth & Development) (Required until fall 2014)

Science Courses (A&P I, II & Microbiology) must be less than 5 years old unless applicant is a post professional BS degree conferred student, or has a conferred Health - related Associate of Applied Science Degree. (A post Baccalaureate-Degree student is defined as a student who currently holds a bachelor's degree and is now pursuing the Licensed Practical Nurse Diploma).

Attend a *Mandatory* Pre-Nursing Orientation Session (Check Nursing website for dates & times)

Obtain a Criminal Background Check from a MGCCC Campus Police office. The CBC result is required prior to submitting the application. Please check the program's website for the Campus Police testing times.

Achieve a composite score of 60 or above on the ATI TEAS exam (The ATI TEAS update is scheduled August 30, 2016. The TEAS V test score will no longer be accepted following the spring 2017 enrollment class. Thereafter, only the new TEAS test will be recognized. (Check nursing website regarding TEAS Registration, Testing, and Remediation.

Achieve a composite score of 18 or above on the ACT (Enhanced Version - Fall of 1989 or later). An ACT score (Enhanced Version) of less than 18, can be waived by successfully completing 24 semester hours of degree-required courses (including A&P I, II and Microbiology) with a GPA of 2.5 or higher.

Achieve a GPA of 2.5 or higher on required pre-requisite courses, plus any other degreerequired nursing courses completed.

After successful completion of the above requirements (excluding BIO 2524, ENG 1123, EPY 2533, and the computer Competency), the student may submit the application for Program Admission. Or, the student may elect to complete all non-nursing courses prior to making application. Applications are submitted to a Nursing Counselor at the JD, JC, Perkinston or George County Campus or Center.

Application Deadline: July 1st (Applications accepted beginning April 15th)
