- _____ Hold a minimum Grade Point Average (GPA) of 2.0 on college work.
- _____ Hold a current American Heart Association CPR for Healthcare Providers certification
- _____ Obtain a Criminal Background Check from a MGCCC Campus Police office. The CBC result is required prior to submitting the application. Please check the program's website for the Campus Police testing times.
