**Test of Essential Academic Skills (TEAS) REGISTRATION FORM**

*If you have questions about the TEAS, contact the nursing program office at your campus or center.*

1. TEAS is a computer-based test of academic preparedness that is used as part of the selective admissions criteria for the practical nursing program at MGCCC. The TEAS provides profiles in math skills, reading comprehension, science reasoning, and English usage.
2. You must apply to be accepted by the college before you will be allowed to take the TEAS at Mississippi Gulf Coast Community College.
3. Go to an MGCCC Learning Lab or purchase materials from the ATI Testing web site ([www.atitesting.com](http://www.atitesting.com)) to review for the TEAS (optional).
4. Proof of payment and a picture ID is required to test. No other items will be allowed in the Assessment Center during testing.
5. Make an appointment at <http://www.appointmentquest.com/provider/2070047424/login>. The entire test session will take approximately four hours to complete.
